### **Summary Annual Report for SHEET METAL WORKERS LOCAL 265 SUPPLEMENTAL RETIREMENT SAVINGS PLAN**

This is a summary of the annual report for SHEET METAL WORKERS LOCAL 265 SUPPLEMENTAL RETIREMENT SAVINGS PLAN, EIN 36-3911499, Plan Number 002, for the period June 1, 2001 to May 31, 2002. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Basic Financial Statement**

Benefits under the plan are provided by a trust. Total plan expenses were \$867,022. These expenses included \$105,320 in administrative expenses, and \$761,702 in benefits paid to participants and beneficiaries. A total of 2763 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$46,401,455 as of May 31, 2002, compared to \$36,592,619 as of June 1, 2001. During the plan year the plan experienced an increase in its net assets of \$9,808,836. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$10,675,858 which included employer contributions of \$9,108,638 and earnings from investments of \$1,567,220.
