Summary Annual Report for SHEET METAL WORKERS LOCAL NO. 265 WELFARE FUND

This is a summary of the annual report for SHEET METAL WORKERS LOCAL NO. 265 WELFARE FUND, EIN 36-2356062, Plan Number 501, for the period July 1, 2004 to June 30, 2005. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of the assets, after subtracting liabilities of the plan, was \$19,138,756 as of June 30, 2005, compared to \$14,814,235 as of July 1, 2004. During the plan year the plan experienced an increase in its net assets of \$4,324,521. This increase includes unrealized appreciation or depreciation in the value of the plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$26,057,877, which included employer contributions of \$23,353,813, employee contributions of \$1,664,730 and earnings from investments of \$1,039,334.

Total plan expenses were \$21,733,356. These expenses included \$2,454,240 in administrative expenses and \$19,279,116 in benefits paid to participants and beneficiaries.
