**\*\*NOTE:** Residential Journeyman hired prior to 6/1/86 shall in addition, receive full Local Pension Contribution in the amount of \$7.44 per hour

\*Residential Trainees: The first 90 days of employment there would be no NPF contributions due on the trainee's behalf. The 91st to 364th day of employment the trainee would receive a pension contribution for all hours worked of \$0.05 cents per hour.

After the first year of employment the residential trainee would receive a NPF contribution equal to 55% of the current residential journeymen's contribution rate.

That amount would be in place for the remainder of the training period as spelled out in the current Collective Bargaining Agreement between the Association and Union.

Residential trainees working light commercial would have their benefits paid to them at the same rate shown in the residential wage data sheets that would be agreed to by the Association and the Union when working on residential work. The Trainee would receive the base wage as listed in the wage data sheets when working on light commercial work as defined in the current agreement.
